Staying on top of today's many different payment processing options including Check 21, mobile banking, remote deposit etc, is proving challenging for many credit unions. Checks remain a favorite target of scammers so it remains up to credit unions to install strong controls around check handling. We help our credit union clients via our robust Check 21 programs that include the following benefits:

- Storing all receipt and check information in the local imaging repository.
- Making transactions immediately accessible through MVi's e-View home banking interface.
- Providing electronic communication to the members that their recent transaction has been recorded
- Providing secure, archival records of each transaction.

Our Laserfiche ECM repository also makes it possible to archive and research this information should it be needed in the future. Future enhancements include tying into a national database to verify account and routing numbers and insuring funds availability prior to the deposit of the check item.

MVi's complete Check 21 suite includes the following modules:

- Check 21 Forward. The ability to send ICL clearing files to the Clearinghouse of choice.
- Check 21 Receive. Provides the capability receive and store all cleared checks information as provided back from the Federal Reserve
- Check 21 Return. Provides the credit union with the ability to return items direct to the FED or clearing house of choice.
- IRD Reprint. Allows for the creation of Image Replacement Documents (IRD's)
- Check 21 Mobile Capture. Provides members with an integrated mobile check capture solution and allows them to take a picture with their smart phone and process it via the C21 forward program.
- Member Remote Deposit. Provides a secure web based interface that allows members the ability to scan their checks at home and upload their images for deposit 24 hours a day.
- Remote Deposit Capture. For business members that have a greater volume of checks, RDC allows the scanning and uploading of deposit items through a secure communication channel that can be processed via C21 forward.
- e-View. MVi's unique home banking interface that allows for Secure Sign on (SSO) capabilities with the credit union's current Home Banking provider. E-view allows not only cleared check images but all deposit items to be displayed via the home banking interface when used with the Teller C21 module.
